Cellist Peter Wiley and Pianist Anna Polonsky will perform Sunday, March 26, 2023, 2:30 pm, at the Munson-Williams-Proctor Arts Institute, 310 Genesee Street, Utica NY. Their program includes works by Beethoven, Schumann, Barber, Mendelssohn and Franck. Cellist—and Utica native—Peter Wiley enjoys a prolific career as a performer and teacher. He attended the Curtis Institute at just 13 years of age, under the tutelage of David Soyer, and continued his impressive youthful accomplishments with his appointment as principal cellist of the Cincinnati Symphony at age 20, after one year in the Pittsburgh Symphony. He made his concerto debut at Carnegie Hall in 1986 with the New York String Orchestra conducted by Alexander Schneider.

From 1987 through 1998, Mr. Wiley was cellist of the Beaux Arts Trio. He succeeded his mentor, David Soyer, as cellist of the Guarneri Quartet from 2001 through 2009. Awarded an Avery Fisher Career Grant, Mr. Wiley was also nominated for a Grammy Award in 1998 with the Beaux Arts Trio, and in 2009 with the Guarneri Quartet. He has maintained a close association with the Marlboro Music Festival for over 40 years.

A much sought-after teacher, Mr. Wiley has been a faculty artist at Caramoor’s “Rising Stars” program, and taught at the Cincinnati College Conservatory of Music, Mannes College of Music, and Manhattan School of Music. He is currently on the faculty of the Curtis Institute of Music and the Bard College Conservatory of Music.

Pianist Anna Polonsky, a Steinway Artist, is widely in demand as soloist and chamber musician. A frequent guest at the Chamber Music Society of Lincoln Center, Ms. Polonsky collaborates with chamber ensembles and soloists of note, performing at chamber music festivals including Marlboro, Music@Menlo, and Caramoor, as well as Bargemusic in New York City. Ms. Polonsky has toured extensively throughout the United States, Europe, and Asia.

Ms. Polonsky made her solo piano debut at the age of seven at the Special Central Music School in Moscow, Russia, emigrated to the United States in 1990, and attended high school at the Interlochen Arts Academy in Michigan. She received her Bachelor of Music diploma from The Curtis Institute of Music under the tutelage of pianist Peter Serkin, and continued her studies with Jerome Lowenthal, earning her Master's Degree from the Juilliard School. Currently, she serves on the piano faculty of Vassar College, and in the summer at the Marlboro and Kneisel Hall chamber music festivals.

Together with violinist Jaime Laredo, violist Milena Pájaro-van de Stadt, and cellist Sharon Robinson, Ms. Polonsky is a member of Espresso! Piano Quartet. With the clarinetist David Shifrin and cellist Peter Wiley, she performs with the Polonsky-Shifrin-Wiley Trio.

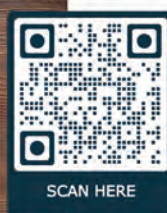

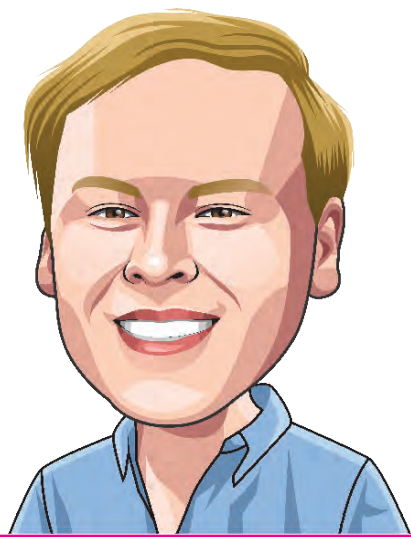

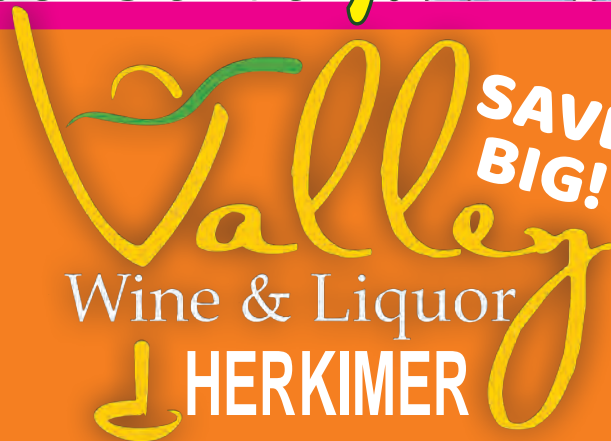

NHFD News

Your New Hartford Volunteer Fire Department responded to 103 alarms during the month of January 2023. The monthly call report is listed below by category.

Fires = 4
EMS = 53
Hazardous = 0
Service Type = 22
Good Intent = 7
Other Alarms = 17
Weather Related = 0
Other = 0
Total Calls for the Month of January 2023 = 103.

Of the 103 alarms, 86 were in the town and 13 were in the village and 4 mutual aid alarms.

Some of the calls listed above - such as Fires, EMS, and Hazardous - are self explanatory. Others such as Service, Good Intent and Other Alarms are not. Service Calls includes water or animal problems, public assistance or standbys. Good Intent refers to responding but did not find anything or canceled in route. Other alarms include explosions, carbon monoxide, smoke or sprinkler detector activations.

The figures above do not include other activities by members of the department such as Fire Prevention details, training, parades, Open House and other various department committee meetings that take place throughout the year.



Since the 1950's, The New Hartford Volunteer Fire Department is proud to have a contingent of Fire Police members who answer the call of duty when the need arises. These individuals must attend and pass a specialized 21-hour training course. Upon completion, they must meet all the requirements under the New York State General Municipal Law, Section 209 (C) and Article 41 of the New York State CPL, Section 2.1.0 after which they take an oath of office and become sworn officers of the law – known as Peace Officers. As a Peace Officer, they are empowered with full police powers, including that of arrest if need be, but just as important, these individuals are responsible to protect fellow firefighters and their equipment while protecting the public from the dangers in and around a fire emergency incident scene. These individuals are listed with the Central Registry of Police and Peace Officers at the New York State, Division of Criminal Justice Services, Office of Public Safety, in Albany.

Currently, ten individuals serve as active Fire Police members although additional department members have completed the course but remain as active firefighters. The public will recognize these individuals by their bright “safety” lime yellow outerwear which maybe a jacket, vest, or raincoat, depending upon the time of year and weather conditions. They are issued strobe hand lights and other traffic safety equipment to assist them in carrying out their responsibilities. The latest piece of equipment is an “Emergency Scene Ahead” road sign.

Their duties are as follows:

To regulate traffic at emergency scenes - In order to protect firefighters from potentially dangerous outside interference, the Fire Police detachment regulates traffic at the scene of any emergency to which the department has been called.

To protect the general public at the scene of a fire - Residents, owners, occupants, relatives, transients, spectators, and even the news media might inadvertently hamper firefighting operations; therefore, Fire Police use tact and courtesy to prevent them from being harmed or obstructing those operations.

To keep fire areas clear for firefighting purpose -

Fire Police provide room for apparatus, emergency vehicles, service vehicles, and firefighters' personal vehicles, among other things, park, operate, turn around, perform tanker operations, and lay hose lines.

To protect the equipment of a fire company - Fire Police keep all non-firefighters away from- and especially off- department vehicles and equipment in order to prevent damage and possible injury.

To enforce the laws of New York State relating to firematic activities and firefighting techniques - The reckless disregard for safe driving within an emergency area, driving over fire hoses, disrespect for fire lines, and non-emergency vehicles intrusions, comprise just the tip of the iceberg of undesirable situations that Fire Police must prevent.

To cooperate with the NHPD - Owing to their common causes of protection, safety, and order, the Fire Police cooperate regularly with the New Hartford Police Department.

To protect the property - at the scene of a fire until the Chief releases the fire police from duty and turns the responsibility over to other police agencies or to the owner.

To carry out the orders of the Chief – The Chief is in command at all fires and emergencies.

Although, Fire Police prevent unauthorized entry into the scene, they remain alert to the fact that bystanders may possess critical information. In addition, they protect the scene's evidence and report unusual events or happenings.

When the public approaches a scene, Fire Police members may ask you to slow down and in some cases – move over. This is to protect the emergency personnel and yourself against potential, and sometimes unfortunate, situations.

For the safety of 1st responders, police officers, tow truck operators and all emergency personnel, New York State enacted the New York State- “Move Over” Traffic Law – VTL 1144-a(a). The law requires motorists to move over and change lanes -when it is safe to do so- to give a safe clearance to law enforcement officers, firefighters, ambulance operators, utility works, tow truck operators, and sanitation workers to operate during and including an emergency situation. In some cases disabled vehicles are included when there flashers are on.

Under VTL 1144 a (a), fines can range up to \$150 for the first offense and up to\$ 300 for the second offense within 18 months with 2 points on your license.

The Fire Police remind you, and it is always a good practice, to know alternate routes in case traffic patterns or emergency situation arise.

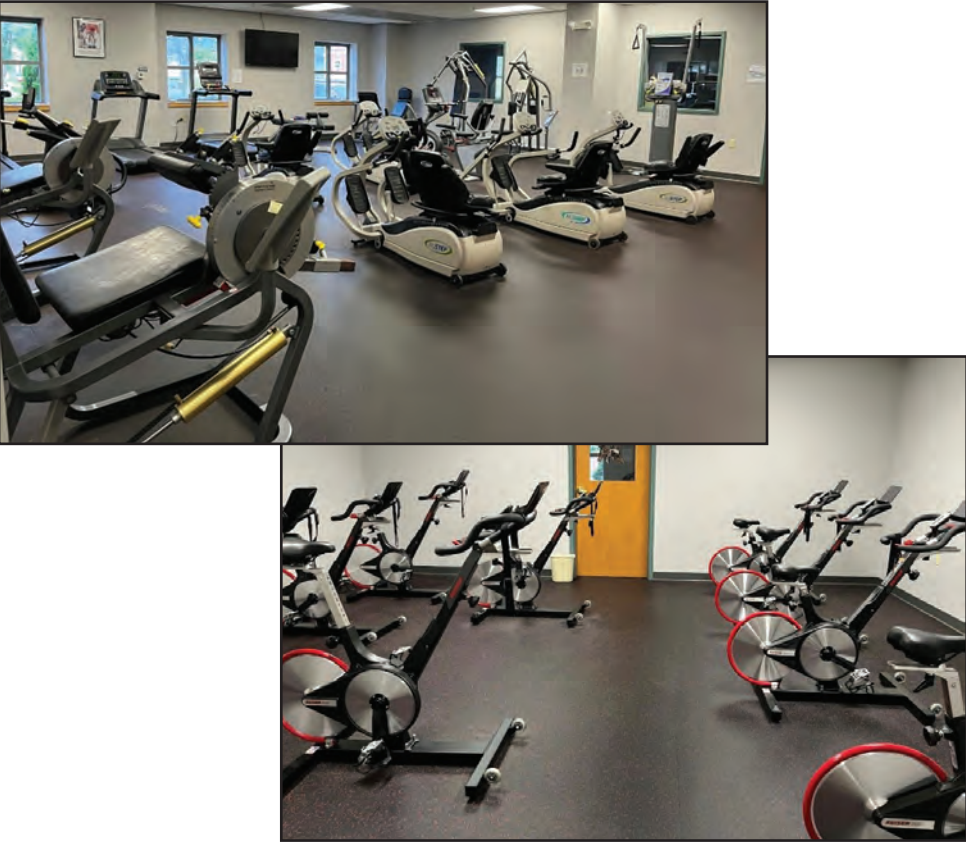

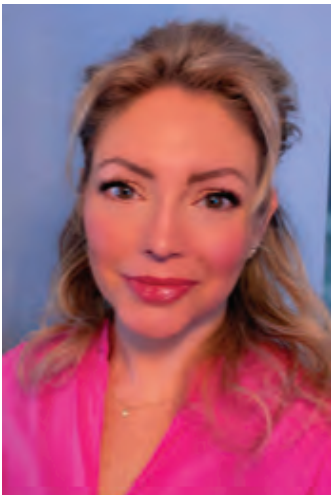

Success

I have some very dedicated clients. I'd like to share some of their successes with you, along with what lifestyle changes they have made to get those results.

Ruth

She was 60 years old and suffered from severe rheumatoid arthritis. She was also a retired physician and recovering alcoholic. She had been sober for a short period of time when she started training with me. She was the most determined client I had ever worked with at that time. I expressed my doubt that I could help her, so she offered me a deal I couldn't refuse. She said, "I'll pay you for six months of training, if you still feel you cannot help me after three sessions, keep the money."

She worked with me six days a week for 23 years, never and I mean never missed a workout. We did Interval Resistance Training, three times a week and a variety of cardiovascular modes the remaining three days a week. Each workout concluded with a series of aggressive stretching movements. According to her doctor, Ruth's rheumatoid arthritis progressed at a dramatically slower pace than expected. Her resistance

movements were with a combination of dumbbells and Nautilus equipment. Her body weight remained at 118 pounds, at 21% body fat for the entire 23 years, while her 15 repetition maximum doubled in all exercises and her VO2 max (Ability to consume and utilize oxygen) also doubled. She also remained sober the entire time.

Nick

He began training with me six years ago after having gastric bypass surgery. He had lost 75 pounds, but was experiencing a metabolic setback and was gaining a pound every week. Some of my gastric bypass clients experience a metabolic "slowdown," due to a very restrictive caloric intake. He was very interested in engaging in a resistance training program, in order to gain strength and build muscle. I informed him, it would also serve to increase his metabolic rate, both during exercise and at rest.

I suggested he also perform "non jarring" cardiovascular exercise 5-6 days a week. Three of those days involved doing 5-10 minutes of cardio, several times a day, in order to boost his metabolism. The remaining three cardio days were done in a continuous manner for 30-45 minutes.

28 years ago, a woman called from Virginia. Her Dad had a less than stellar, annual medical checkup. His doctor told him he needed to lose 50 pounds and exercise regularly or else? She had talked to a friend, who is also a member of our fitness center, and wanted to purchase 16 sessions with me for her Dad's birthday.

He started with me the next day, somewhat reluctantly. We met three times a week, doing Interval Resistance Training at a fairly high intensity. He has seldom missed a workout in 28 years and has also adopted

a moderately low calorie diet, still keeping a daily nutrition log, that he allows me to peruse regularly. He lost 50 pounds during his year of training and has kept it off for 27 years! His dyastolic blood pressure is down from 96 to 78 and his systolic blood pressure is down from 148 to 120!

During the past 28 years, he has had both knees replaced. Six weeks before each surgery he began an aggressive prehabilitation program that enhanced his overall recovery.

It's a lot of fun training such dedicated and driven people.

Arise & Go is an exciting Celtic trio that finds its roots in the dance music of Ireland, Scotland and Atlantic Canada. Blending pipes, whistles, fiddle, and guitar, the group's varied musical backgrounds combine to produce a sound which is both grounded in tradition and uniquely fresh and driving. From intimate house concerts to festival stages, Arise & Go has been hailed for their "precision and energy".

Arise & Go, winners of North America's longest running live folk radio broadcast Best of Bound for Glory Award 2018, has been featured in Irish Music

Magazine, Roots Music Canada, The Boston Irish Reporter and the Irish American News where they have been praised for "musical complexity and colour" that is also "authentically mindful of tradition". 2019 saw the release of the band's new album meeting place showcasing the different Celtic traditions that each brings to the group's sound.

Ellie Goud, from Quispamsis, New Brunswick, grew up steeped in the Atlantic Canadian musical tradition. Her style combines Celtic and Acadian influences from Canada, Ireland and Scotland. She began playing fiddle at the age of 9 through the traditional music program at her elementary school, and was introduced to Acadian music from her neighbor Jean. Her sound is uniquely New Brunswick – a cutting blend of Scottish and Acadian rhythms and sounds. Ellie has performed as a solo artist and in groups in venues such as La Salla Rosa and L'Escalier in Montreal, Bound For Glory, the Victoria Folk Festival, and Information Morning Live at the Saint John City Market.

Piper Michael Roddy, from Utica, NY, has spent over 20 years creating his unique combination of Scottish and Irish piping styles. After years of competitive success with the Mohawk Valley Frasers Pipe Band, Michael turned to the world of bellows piping, making the natural leap to smallpipes and border pipes, and the bigger leap to the Irish uilleann pipes. He has been featured as a piper with the Genesee Symphony Orchestra, The Syracuse Vocal Ensemble, the Mohawk Valley Choral Society, and the Cayuga Vocal Ensemble. Michael is an active teacher and has also premiered several of his own compositions and arrangements for pipes and orchestra.

Tim Ball (guitar, bouzouki, foot percussion) has been a staple of the contra dance and Irish music scenes in western New York for the better part of a decade. An exceptionally versatile musician and relentless collaborator, he performs as a fiddler throughout the Northeast with contra dance bands Tempest and Center Street, and Ithaca's Irish session band Traonach. As a teacher or staff musician, he has been on faculty at week-long camps such as American Dance & Music week at Pinewoods (MA), the Ithaca Suzuki Institute (NY), and the Kanack School Fiddle Camp (Rochester, NY).

thrilled to be coming to share their music at the Irish Cultural Center of the Mohawk Valley on Thursday, March 2, 2023.

2016 was a pinnacle year for Derek and The Young Wolfe Tones when they were chosen to perform on the 24th April at the 1916 centenary commemorations at the General Post Office in O’Connell Street Dublin at 12.0’clock noon. This was the exact same time the Irish proclamation was read by Padraig Pearse one hundred years ago to the minute. As Derek is quoted as saying “of all the honours bestowed on the Wolfe Tones old and young, this privilege was the most significant. It was an honour to perform the music and songs of remembrance and the patriotic ballads that were sung by the volunteers inside the building during the struggle for our freedom, and we performed them with the same passion and emotion.”

In 2001, after nearly 40 years performing, the legendary Wolfe Tones parted with their founder and leader – Derek Warfield. No other Irish folk group, before or since, told the story of Ireland so completely and unapologetically. But for Derek’s hunger and desire to continue to further the story of Ireland through song, an ancient tradition might have lost perhaps its most iconic figure. In 2008, Derek put together a band containing some of the finest musicians and singers in Irish music – The Young Wolfe Tones.

Derek Warfield’s 50 years of experience coupled with the talent and energy of The Young Wolfe Tones brings the old tradition of Irish balladry into a new age. The story of Ireland is transmitted in their music and song and illuminated by the outstanding musicianship of these wonderful ambassadors of a new generation of traditional players. The virtuoso partnership of England’s premier flatpicking guitarist and “the greatest Celtic harper of our age” (LIVE IRELAND) has by now brought its unique musical vision to twenty-two countries on five continents. These soon became the norm amongst both her contemporaries and the younger generation of Irish players, thus enabling the renaissance of the instrument that has taken place in the last thirty years. In 2001 she received Irish music's most prestigious award, that of Traditional Musician of the Year - Gradam Cheoil TG4 - "for the excellence and pioneering force of her music, the remarkable growth she has brought to the music of the harp and the positive influence she has had on the young generation of harpers".

She won the All-Ireland and Pan-Celtic Harp Competitions several times and in 1985 recorded the first harp album ever to concentrate on traditional Irish dance music, The New-Strung Harp - "an intensely passionate and intelligent record and a milestone in Irish harp music" THE IRISH EXAMINER. Her approach has been profoundly influential - “a single-handed reinvention of the harp”.

Chris and Máire's performances are rooted but eclectic, emotional but adventurous: a breathtaking blend of traditional Irish music, swing jazz and bluegrass, coupled with striking new compositions.

As spring continues on, we will be filling potholes on our many streets. If you think we have missed one on your street, please reach out to us.




This is a continuing discussion of Legal Myths and Reality, because those informed are the most successful.

MYTH: New York State fathers in all situations have the same rights as mothers.

REALITY: Up to recently this was not true. Now the New York State Governor has signed the Parental Equity Act. This new law secures rights for biological fathers who are not married to the mother of their child, and who contest their child’s adoption by a third party.

Prior to this law the biological father of a child could contest an adoption of his child only if he had kept a certain level of contact with the child, and paid child support. However, such a father was not entitled to a

court hearing on those issues to determine what actually happened with the child. Those who support the new law say that the previous law put undue burdens on fathers that did not exist for single mothers and for married but separated fathers. They say that under the old law mothers and fathers were treated unequally. They further say that the prior laws were outdated and based on an assumption that if the father was not married to the mother, he was not going to be involved in his child’s life regardless of which parent made the decision not to marry one another. The new law recognizes that modern fathers can be as involved with their children as the mothers, married to one another or not.

Under the new law a father who has never been married to the child’s mother, can take steps to protect his legal right to a relationship with his child, and can enforce those rights by a hearing in court. This can effectively block an adoption by a third party. The organization New York Attorneys for Adoption and Family Formation oppose the law because they say that it would make adoption proceedings more complicated, lengthier and expensive for the adoptive parent, and that that cannot be helpful to the child. Unmarried fathers applaud the law.

MYTH: The issue of mandatory COVID 19 vaccination in New York State is settled.

REALITY: This is a continuing issue as more information becomes available about COVID 19 and its variants. In mid-2021 the State Legislature gave emergency power to the Governor to deal with the ongoing crisis of COVID. That power continued until June, 2022. The same month in mid-2021 the New York State Health Commissioner, as part of the Governor’s administration, made the requirement to be vaccinated permanent for healthcare workers. The Commissioner said in effect that those who are vaccinated are less likely to develop serious illness, be hospitalized or die than those unvaccinated. Further, the Commissioner believed that vaccinations helped reduce transmission of the early variants of the virus. The U.S. Centers for Disease Control and Prevention agrees with these principles. They note, however, that breakthrough infections occur and are more likely with more recent variants of the virus, and are less effective therefore in reducing transmission of later variants. Nevertheless, they assert that vaccinations continue to reduce serious illness, hospitalization and death. They point to various studies to support their findings.

In December, 2021, the U.S. Supreme Court refused to block the requirement that healthcare workers be vaccinated.

The Medical Professionals for Informed Consent, some of whom lost their jobs or were at risk of losing their jobs in the medical field because they refused the vaccination brought a lawsuit against New York State.

The case was assigned to Syracuse judge Gerard Neri. Judge Neri sided with the Medical Professionals for Informed Consent’s position. He ruled that only those vaccinations that are specifically stated in New York Public Health Law can be the subject of a requirement to vaccinate. Some of those are mumps, measles and hepatitis. He said that the power to impose the COVID mandate belongs to the Legislature, and not to the Governor or the Governor’s administration. Therefore, it is null, void and of no effect.

The State contends that the mandate was not irrational or unreasonable and was backed by other court decisions. The State also contends that the Legislature may give such emergency powers to the Governor to deal with an ongoing health crisis, as happened in this case.

The State has not yet announced if it will appeal Judge Neri’s decision to a higher appeals court. Stay tuned.

MYTH: Our criminal legal system was invented from the time of the start of our country.

REALITY: Our legal code is based on the English Common Law, which was developed in England after 1066. However, because the Romans were in England and Wales for about 400 years starting around 43 A.D., the developing English law was influenced by four main principles of Roman law. These are: 1. A charged person is innocent until proven guilty; 2. The accused can face their accuser; 3. The accused can offer a defense and is entitled to a trial; and 4. Guilt must be proven “cleaner than daylight”. (We say “beyond a reasonable doubt”, which is the same thing).

All these principles are amazing, but development of the first one is almost unbelievable! It seems natural that if I accuse you of a crime, and you deny doing it, then you should be expected to show proof that you did not do it. For instance, if I say that you hit me, you may say “I did not and my neighbor will tell you that I was not even there”. And yet, the Romans, with their brilliant law codes, reversed the natural process by requiring that I prove you were there and hit me. Until then, you

are presumed to be innocent. We have adopted this principle and have maintained it for over 2000 years! Why fix a principle that is not broken! What an amazing advancement of justice!

For comparison, Mediaeval Wales worked differently. An accused could deny the charge under oath, and then find a certain number of persons to swear under oath that they believe the oath of the accused. The issue is not what the witness saw or knows but whether the witness believes the accused to be honest. This is called compurgation. For a homicide, the accused had to find 300 people who would swear to the accused’s honesty. If you once lied as a compurgator, you could never be called again.

Attention to legal myths can be important. They can be a starting point for developing an interest in the law. However, if specific legal issues are important in your life, for instance, regarding custody of children or money payable for any reason, it is wise to consult a lawyer who can advise you on the truth of legal myths. “From the Mailbag”

Q. I found this Utica Club beer tap in a box of my grandfather’s belongings that were given to me when he passed. He ran a tavern locally in the 1930-40’s. I would never sell it but I’m curious if these of any particular value?

A. Your bakelite beer tap does date from the period your grandfather ran his establishment. It is indeed very collectible. There are many collectors of breweriana, some of which specialize in beer taps. I would value your beer tap at \$100-150. I think its nice that you are keeping it for its sentimental value.

Q. I have a pink depression glass covered candy dish. I know that it was made by Anchor Hocking. Can you tell me anything else about it and its possible value?

A. I did a little research and can tell you that the pattern is Mayfair “Open Rose.” This was one of Anchor Hocking’s most popular patterns. The values for depression glass and most antique glassware are down considerably from their highs in the 1990’s. I would value it at around \$40. Interestingly, Anchor Hocking has been in production since 1905 and is still made today in the USA.

Q. I remember an older gentleman that used to conduct estate sales in Utica decades ago. I was telling my daughter about him but couldn’t remember his name. I thought you might know?

A. Without a doubt I know who you are talking about. He was Leo Albert Buskey. He was very active in the 1960’s and 70’s in conducting estate sales in Utica and the surrounding area. He billed himself as an antiquarian and was very knowledgeable about Wedgwood China and studied at the Wedgwood factory in England. His pricing of items was a little peculiar in my opinion. I have told the story in this column about going to an estate sale of his in Utica with my father. There was a beautiful dining room set and the table was covered with a tablecloth that caught my father’s eye. There was a tag on it marked \$10,000, which my father assumed was for the whole dining room set. He asked me to find out how much the tablecloth was and Mr. Buskey said “The price is on it- \$10,000.” Needless to say we left without a tablecloth.

Real Estate Investment Trusts: Pros and Cons

“An investor might think, ‘You know, I’ve always wanted to own an apartment complex as an investment that generates extra income,’” says John LaForge, senior lead wealth investment solutions analyst at Wells Fargo Investment Institute. “But individual investors may have a difficult time getting a loan on such a big property.”

This is where real estate investment trusts (REITs) come into play. REITs can be purchased like stocks, and they pay investors regular dividends that can serve as income. “REITs are kind of a hybrid of stocks and bonds,” LaForge says. “They have some stock qualities and they trade like a stock, and then they have some income qualities, more like a bond. So adding them to a portfolio can often help diversify your investments.”

In this Q&A, LaForge answers five common questions about REITs to help you weigh the potential benefits and risks to help you decide if they’re the right fit for your portfolio.

What are they?

“A REIT is a company that owns a number of real estate properties and packages them into a security that you, as an investor, can buy into,” explains LaForge. “It’s packaged so you can purchase shares of real estate much like you would a public company’s stock. It’s a popular way for investors, especially small- to medium-size investors, to invest in various kinds of real estate to produce income.” Different REITs bundle different types of real estate — everything from apartments and senior care facilities to cell phone towers and industrial warehouses — all over the country.

“There are two main qualifications a company needs to meet to be classified as a REIT,” continues LaForge. “Number one, at least 75% of the business must be involved in real estate. That means they essentially buy and maintain real estate, collect rents, and such. The

second qualification: Once they collect those rents, 90% of that income has to be passed on to shareholders.”

What are the potential benefits?

LaForge says that one of the greatest potential advantages of investing in REITs is easily overlooked: “These trusts are managed by people who know real estate potential, and you get access to their expertise,” he explains.

Secondly, because the trusts pool money from many other investors, REITs have access to a lot of capital to invest in the best properties — properties that would otherwise be out of reach for many individual investors.

And then there’s the income they provide through their dividends. LaForge says, “REITs can be a way to diversify your income, particularly when bond yields are low.”

How can you find a good-quality REIT?

There’s a lot that goes into determination, LaForge says. But two key numbers to explore are the dividend yield and the REIT’s price change over time.

“Typically, the REITs with the highest dividend yield are, on average, weaker financially,” LaForge says. “The high yield is there to attract investors because the REIT needs that capital. The true quality REIT that has great management and great properties typically has a lot of very interested investors, which drives down the dividend yield. In other words, many times the REITs with the lowest dividend yields are the highest quality.”

While it might make REITs seem less beneficial if the highest-quality options pay the lowest dividends, it’s important to remember that a REIT trades like a stock, so the price has the potential to appreciate over time. “Over the long term, the price appreciation of a quality REIT tends to beat out any REIT that has a high dividend,” LaForge says.

What are the income tax implications?

“When you get your REIT’s dividend payment, it can come in the form of ordinary income, capital gains, or even a return of capital, and that will show up on the 1099 that you get for your tax preparation,” LaForge says. “Usually, that income’s taxed at the individual level, at the marginal tax rate. So if you have a very high tax rate as an investor, you will want to talk to your accountant or tax advisor about the impact of investing in REITs. You might get a 4% yield in a REIT, but by the time you’re done paying your 40% tax — if that’s what your marginal tax rate is — you might have been better off owning a municipal bond that’s generally tax-free.”

What risks are associated?

The greatest investment risks with REITs tend to be

related to the economy, LaForge says. “There is always a chance in a recession that the REIT has properties that aren’t doing well.”

Another consideration is related to increases in interest rates. “If interest rates rise and your government bond goes from 1.5% to 3%, an investor may look at their REIT paying 4% and say, ‘Maybe it’s not worth it anymore,’ because the government bond is considered lower risk than that REIT. It causes a crowding-out effect, where the increase in interest rates takes money flow and capital away from the REITs.”

H.A.R.P. Museum Issues Call for Artifacts

Utica’s Irish Cultural Center H.A.R.P. Museum is looking to the public to help build a new “On This Hallowed Ground” exhibit. The Irish Cultural Center of the Mohawk Valley was constructed on the exact spot of the original St. Patrick’s Church, built in 1850 by a burgeoning Irish Catholic population. The site was specifically chosen by the Ancient Order of Hibernians’ John C. Devereux Division and the Great American Irish Festival when looking to build a Hibernian hall to celebrate and promote the Irish culture. The H.A.R.P. Museum, located on the Center’s second floor, is planning a permanent exhibit to trace the history of the site – considered “hallowed ground” by Utica’s Irish community – and is looking for artifacts, material, documents and photos to help tell that story. The exhibit, called “On This Hallowed Ground,” will trace the history (and pre-history) of the Irish Cultural Center, relating events of importance throughout its history, including St. Patrick’s construction, its destruction by fire in 1889, its being rebuilt in 1895 and finally the sad period where it was closed as part of a diocesan consolidation effort; ultimately being demolished in 1968. The exhibit will take the viewer up to and through the establishment of the Great American Irish Festival as the primary funding vehicle for the Irish Cultural Center, wrapping up with artifacts and documents that trace the current Center’s construction and grand opening. If you have anything that you feel could help tell the story of the history of this site – maybe a first Communion dress from St. Patrick’s during its glory days, a class photo from St. Patrick’s School or documentation regarding the church and its priests – museum officials would love to make them a part of the displays. New Hartford High Schools Storied Football Program

This past month, the New Hartford Central School and the entire New Hartford community lost one of it’s most iconic Coaches. Coach Don Edick passed away on February 6th at the age of 91.

The New Hartford School District has always produced high achieving athletes and the football program is no exception. It is a credit to the coaches that the school has had the good fortune to attract to the district. And one of the most prolific coaches to step on the sports fields was Don Edick.

Don was born in Rome and graduated from RFA where he was a all-star on the varsity football team from 1946-1949. After graduating he would proudly serve with the United States Marine Corps before college. He started his coaching career with the Brookville Ohio High School as a line coach after graduating from the University of Dayton in 1959. In 1960, Don came to New Hartford and served under then new coach Norm Anderson. Don would also coach baseball at New Hartford. As Head Coach from 1971-1976 and then again from 1981-1994, Coach Edick had an extraordinary record including four straight Section III champions, seven division champions and three undefeated seasons. In 1988 the team was ranked 4th in the state and in 1989 it was ranked 2nd! From 1977-1981 Don served as the Districts Athletic Director.

New Hartford Rotary News

When you join Rotary, you become a member of a world renown service organization that has 46,000 clubs and 1.4 million members throughout the world. This enables a very unique opportunity for a club like our New Hartford club, made up of 20 members, to help and assist Rotary clubs located halfway around the world. Since the 1980's, Rotary has been the driving force to eliminate polio in the world. And in our efforts to do this, we have developed partnerships with other Rotary clubs all over the world which has enabled us to help out in many other ways. One such partnership was started several years ago between the Rotary Clubs of Fulton, NY and Fulton, MO. Sharing a common name brought these two clubs together and the New York club soon learned of a project that the Missouri club was involved in in Tanzania, Africa. A Member of the Missouri club had traveled to Africa to assist in the distribution of the polio vaccine when he learned of the Oltepeleki Village, near the border with Kenya, that had experienced tragedies in their efforts to educate their children. This area is a very wild, hilly portion of Tanzania and the children had to walk for several miles to attend the nearest school. Unfortunately, in the past years, some of the children

were killed by cape buffalos while walking to and from this school, but could have just as easily been attacked by the lions and poisonous snakes that inhabit this area as well. Through the efforts of the Missouri club and some local Tanzania clubs, they were able to construct a very crude mud/stick classroom, so the children would not have to traverse these wild jungle trails to attend school. Now both the Missouri and New York clubs have entered into a project to provide funds to build a better concrete block classroom, as well as a latrine and rainwater catchment system. The children who now attend this very crude school still have to go into the bush to go to the bathroom and consequently, are still subject to wild animal attacks. Also, the ground water in the area is not suitable for drinking, which is why a rainwater catchment system is very important for the children to have clean drinking and bathing water. Now, the Fulton, NY club and District 7150 have set a goal for all 43 clubs in District 7150 to raise \$20,000.00, which is the amount needed to construct the concrete block classroom, latrine and rainwater catchment system plus supply the school with some basic school equipment. This equates to an average of a \$465.00 donation from each club in the district. As of this printing, New Hartford Rotary has raised \$676.00 towards this project.

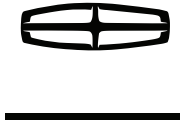

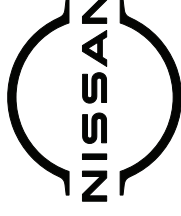
